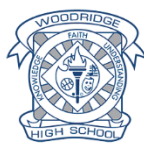

During Thursday Periods 3 and 4, and during Periods 1 to 4 on Fridays, our students engage in their classes via their online classroom (eLearn – Blackboard Collaborate). During this time, students can be learning from anywhere!

This allows students the flexibility to negotiate with you as their parent/guardian where the best place is for them to learn during this time. They may stay at home, go to a family member or friend's house, or go to our Logan City Council Library. As long as they have a device and internet access, they can engage in their learning online.

For families that can not cater for their student to be off school-site during these lessons, we will provide a safe space for these students.

As outlined in the Education (General Provisions) Act 2006 it remains our obligation to mark rolls, monitor attendance and inform you if your child has not arrived at school each morning via same day text messaging. We look forward to continuing our work with you to ensure you feel supported in meeting your parental obligation as outlined in the Education Act:

177 What is Attendance

(1) A child attends a State school or non-State school only if the child complies with the school's requirements about physically attending, at particular times, its premises or another place.

Part 4 Parents' obligation

239 Obligation to ensure participation

Each parent of a young person in the compulsory participation phase must ensure the young person is participating full-time in an eligible option, unless the parent has a reasonable excuse.

Maximum penalty— (a) for a first offence—6 penalty units; or (b) for a second or subsequent offence, whether or not relating to the same child of the parent—12 penalty units.

We continue to encourage feedback from our school community and welcome you to attend our P&C meetings, which are scheduled for the third Tuesday of each month during the school term.

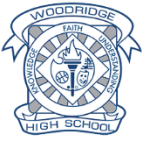

Privacy notice

Activity risks and insurance

Please note that the Department of Education does not have personal accident insurance cover for children/students. If your child is injured as a result of an accident or incident while participating in the activity, all costs associated with the injury, including medical costs are the responsibility of the parent/carer. Some incidental medical costs may be covered by Medicare. If you have private health insurance, some costs may also be covered by your provider. Any other costs must be covered by parents/carers. It is up to all parents/carers to decide what types and what level of private insurance they wish to arrange to cover their child. Please take this into consideration in deciding whether or not to allow your child to participate in this activity.
